

MASS EVENT REGULATIONS

Gdansk University of Technology's Students Festival "Technikalia 2025"

1. The organizer of the mass event under the name of Gdańsk University of Technology's Students Festival "Technikalia 2025" (hereinafter referred to as the Event) within the meaning of the provisions of the Act of March 20, 2009, on the Safety of Mass Events (Journal of Laws of 2023, item 616) (hereinafter referred to as the Act) is Gdańsk University of Technology in Gdańsk (hereinafter referred to as the "Organizer").
2. The Event takes place on May 10, 2025, in designated and fenced areas on the premises of Camper Park at the Sports Center of Gdańsk University of Technology, located at Towarowa Street (hereinafter referred to as the "Event Area").
3. These Regulations are the regulations of the aforementioned mass event and has been issued based on the provisions of the Act. The provisions of these Regulations apply to all persons participating in the Event who are present in the Event Area during its duration. This does not apply to persons who have been appointed by the Organizer to ensure safety and order during the Event.
4. Entering the Event Area signifies automatic and unconditional acceptance of these regulations.
5. Only adults with a valid document confirming identity and a valid entrance ticket, which will be exchanged by the Organizer for a wristband immediately before being admitted to participate in the Event or entering the Event Area at the ticket exchange point, have the right to enter the Event Area. In the absence of a valid ticket or wristband, the Organizer reserves the right to ask such persons to leave the Event Area.
6. A document confirming identity means an identity card, temporary identity certificate, passport, driver's license, student ID, document confirming the identity of a foreigner, or other document confirming identity with a photo.
7. All Participants present in the Event Area are required to have a document confirming their identity and to present it upon request by the Organizer or persons authorized by them.
8. The absence of a document confirming identity or refusal to present it entitles the Organizer to demand the immediate departure of the Participant from the Event Area, who then loses the right to stay at the Event Area.
9. It is prohibited to bring or possess weapons or other dangerous objects, explosives, pyrotechnic articles, fire hazardous materials, alcoholic beverages, narcotics, or psychotropic substances onto the Event Area, except for alcoholic beverages purchased at the Event Area, as mentioned in point 29 of these Regulations.
10. It is prohibited to bring, introduce to the Event Area, or possess during the Event:
 - 1) any professional image or sound recording devices, laser pointers;
 - 2) any items or devices that may be used to interfere with the course of the Event or in any other way impede or hinder the smooth conduct of the Event;
 - 3) any heavy, metal, sharp, glass, hard, or other objects that may pose a danger to the Participant bringing them or other Participants, as well as clothing, footwear, bags, or backpacks containing hard or heavy elements that may cause injury to another Participant upon sudden or unexpected contact with their body;
 - 4) flags, banners, or signs that are not directly related to the Event or exceed the size of 4m², or other items that may prevent or hinder other Participants from fully participating in the Event or pose a threat of injury to them; even permitted by the Organizer, flags and banners should be rolled up, and signs should be removed, at every explicit order of the Organizer or persons authorized by them;
 - 5) beverages or food purchased outside the Event Area; 6) animals.
11. In the event of a violation of points 9 or 10 of these Regulations, the Organizer has the right to refuse entry to the Event Area to the person violating or to remove them from the Event Area.
12. Persons under the influence of alcohol, narcotics, intoxicants, designer drugs, psychotropic substances, or behaving aggressively will not be admitted to the Event Area.

13. Each Participant is obliged to behave in a manner that does not endanger the safety of other Participants or other persons present at the Event Area.
14. Each Event Participant is obliged to comply with the provisions of these Regulations and the applicable law and to strictly follow the orders of the authorities or services indicated in point 15 of these Regulations.
15. In order to ensure the safety of the Event, the Organizer appoints the following authorities:
 - 1) Safety Manager - a person appointed by the Organizer who represents them in matters related to ensuring the safety of Event Participants;
 - 2) Information services - persons who are subject to the Safety Manager and have been appointed by the Organizer to inform Event Participants about matters related to the Event;
 - 3) Security services - persons who are subject to the Safety Manager, appointed by the Organizer, and meet the requirements specified in the Act of August 22, 1997, on the Protection of Persons and Property (i.e., Journal of Laws of 2021, item 1995).
16. In accordance with the Act and these Regulations, Security services and Information services are authorized to:
 - 1) check or determine the entitlements of Participants to participate in the Event; in case of lack of such entitlements - to call such persons to leave the Event Area;
 - 2) identify participants to establish their identity;
 - 3) inspect the contents of Participants' luggage or clothing, especially if there is suspicion that they are bringing or possessing items mentioned in point 9 or point 10 of the Regulations;
 - 4) issue order directives to Participants disrupting public order or behaving contrary to the Regulations; in case of non-compliance with these orders - to call such persons to leave the Event Area;
 - 5) apprehend, for immediate transfer to the Police, persons committing prohibited acts or persons directly endangering the goods entrusted to protection;
 - 6) in cases where the conditions referred to in Article 11 points 1 and 2 of the Act of May 24, 2013, on Direct Coercive Measures (Journal of Laws of 2024, item 383) are met, use direct coercive measures referred to in Article 12(1)(a) and (b), point 2(a), and point 12(a) of that Act. The use of direct coercive measures and the documentation of such use are carried out in accordance with the rules specified in the aforementioned Act.
17. The activities referred to in point 16 of the Regulations should be carried out in a manner ensuring respect for human dignity or other personal rights of the person to whom they were addressed.
18. In accordance with the Act and these Regulations, Security services are obliged to:
 - 1) refuse entry to the Event:
 - a) to a person refusing to submit to the actions referred to in Article 20(1)(1-3) of the Act or point 16 of these Regulations;
 - b) to a person against whom a decision has been issued:
 - prohibiting entry to a mass event, as referred to in the Act;
 - obliging to refrain from staying in places where mass events are held, issued by a court against a convicted person in connection with the conditional suspension of the execution of a custodial sentence or against a minor on the basis of Article 7(2) of the Act of June 9, 2022, on the Support and Resocialization of Minors (Journal of Laws of 2022, item 1700, as amended).
 - c) a person subject to a foreign ban issued pursuant to the Act;
 - d) a person subject to a club ban issued pursuant to the Act;
 - e) a person under the visible influence of alcohol, drugs, narcotics, designer drugs, psychotropic substances, or other similar substances;
 - f) a person possessing weapons or other objects, materials, products, beverages, substances, as referred to in Article 8(2) of the Act;
 - g) a person behaving aggressively, provocatively, or otherwise posing a threat to safety or public order;

- 2) refuse entry to the Event for a person without a valid identity document and wristband authorizing them to be present at the Event Area, in accordance with point 5 or 6 of these Regulations;
 - 3) remove from the Event Area persons whose behavior disturbs public order or is contrary to these Regulations;
 - 4) remove from the Event Area persons referred to in subparagraphs 1) (a) - (e) of this point.
19. In accordance with the Act, Information services are obliged to:
- 1) inform about facilities and safety requirements specified by the Organizer or rescue services;
 - 2) inform about the location of medical, gastronomic, and sanitary points;
 - 3) supervise the safe entry and exit of Event Participants;
 - 4) prevent persons attending the Event from entering areas not intended for the public;
 - 5) respond promptly to incidents and threats by taking necessary remedial action, especially by informing Security services about them;
 - 6) observe all areas of potential danger and counteract excessive crowding; 7) ensure compliance with the provisions of these Regulations; 8) respond to complaints submitted by Event Participants.
20. The Organizer may refuse entry or access to the Event Area to persons whose appearance or characterization prevents identification.
21. The Organizer may refuse entry or access to the Event Area if the number of Participants present at the Event Area is at least 10,000.
22. Blocking or obstructing exits and evacuation routes, access roads for rescue services or hydrants, as well as other devices necessary in the event of a rescue or firefighting operation during the Event, is prohibited.
23. If an Event Participant notices a fire or any other threat to persons or property at the Event Area, they are obliged to:
- 1) immediately notify the Organizers or the authority referred to in point 15 of these Regulations;
 - 2) comply with all instructions from the Organizer or the authority referred to in point 15 of these Regulations;
 - 3) head to the marked evacuation exits;
 - 4) avoid causing panic;
 - 5) not obstruct access for rescue services.
24. The Organizer informs that Event Participants may be exposed to continuous exposure to high sound levels, which may cause hearing damage. The Organizer recommends that Event Participants consider using specialized hearing protection. The Organizer is not liable for any hearing damage or health loss incurred.
25. Conducting any commercial activity, fundraising, or other activities on the Event Area during its duration without prior written consent of the Organizer is prohibited. 26. It is prohibited to present slogans or chants during the Event that:
- 1) may provoke or incite disturbances or threats to safety;
 - 2) may be inflammatory;
 - 3) may be offensive or demeaning to others, especially regarding their gender, nationality, race, religion, age, beliefs, political views, sexual orientation, affiliation with subculture, or for any other reason.
27. Event Participants or persons present at the Event Area are prohibited from delivering any speeches or performances of a political nature, presenting slogans or chants as part of an electoral or political campaign, or undertaking any propaganda or political activities.
28. All complaints, comments, or requests regarding participation in the Event can be submitted within 7 days after the end of the Event to the email address: tomasz.toloczko@pg.edu.pl. The Organizer handles complaints within 7 days of receipt. The personal data administrator is Gdańsk University of Technology. Personal data is processed for the purpose of handling complaints as referred to in the first sentence. Providing personal data is voluntary but necessary to receive a response to the complaint. The legal basis for processing personal data is its necessity for the purposes of the legitimate interests pursued by the data controller, which consist in handling complaints. The

administrator may process personal data of Participants for as long as necessary to achieve the purposes for which the data was collected, unless there is a technical, legal, or other important reason justifying the removal, destruction, or anonymization of this data.

29. Alcoholic beverages containing no more than 3.5% alcohol may be sold, served, and consumed at the Event, exclusively in designated areas. Sales and serving may only be conducted by entities holding the appropriate permits, in accordance with applicable law.
30. Sale of alcoholic beverages in hard packaging, especially made of glass, metal, or plastics, which if used improperly may pose a threat to human life and health, is prohibited.
31. The Organizer may record the course of the Event for marketing, documentary, or promotional purposes. The Organizer or persons authorized by them may use such recording or its fragment, including depicting the image of a Participant or another person present at the Event Area, without temporal or territorial limitations, without the need to pay remuneration for the use of the image, within the scope of exploitation defined in Article 50 of the Act of February 4, 1994, on Copyright and Related Rights (Journal of Laws of 2022, item 2509), i.e.:
 - 1) in terms of fixing and reproducing the work - production of specific copies of the work, including by printing, reprography, magnetic recording, and digital techniques;
 - 2) in terms of trading in the original or copies on which the work was fixed - putting into circulation, lending, or leasing the original or copies;
 - 3) in terms of distributing the work in a manner other than specified in point 2) above - public performance, exhibition, presentation, reproduction, broadcasting and rebroadcasting, as well as public making available of the work in such a way that anyone can access it at a place and time of their choosing.
32. Being present at the Event Area is tantamount to consenting to the recording, distribution, or publication of the image of a Participant or a person present at the Event Area during its duration, captured during the Event.
33. In case of disputes not regulated by these Regulations, the decision in such a situation is made by the Event Organizer or another person authorized by them.
34. Matters not regulated in the Regulations are governed by the provisions of the Act.
35. The Organizer has the right to change these Regulations, especially to ensure the proper conduct of the Event or to ensure the safety of Event Participants.

37. The Regulations come into force on the day of announcement and are valid until the official end of the Event by the Organizer.
